On the occasion of the commemoration of International Human Rights Day, the Department of Social Inclusion (DSI) of the OAS Secretariat for Access to Rights and Equity (SARE) sends its compliments to the Permanent Missions to the OAS and has the honor to inform of the launching of the **Digital Diploma in Leadership for Social Inclusion and Access to Rights**, which will be imparted under the framework of the **OAS School of Governance**. This Digital Diploma will take place starting March 9, 2021 until April 15, 2021 with two sessions per week in virtual format, and at no cost to participants.

The Digital Diploma is designed for government officials, members of civil society organizations and other actors in the region with an interest and demonstrated commitment to leading on issues of social inclusion and human rights. Interpretation in the International Sign System will be available.

Some of the topics to be covered in the Digital Diploma include education for democracy and human rights; strategic communication, political and social leadership; situation of groups in vulnerable situations; intersectionality; international and interamerican juridical frameworks; use of social media for incidence in this agenda, among other topics.

The Department of Social Inclusion will receive applications starting on December 10, 2020 until January 31, 2021. Applications should be sent to dis@oas.org.
